Subject: suspension of AML type rating endorsements

Dear Colleagues,

This is to inform you of the following.

Further to letter ILT-2024/3572 of 24 July 2024 where the Netherlands Human Environment and Transport Inspectorate (ILT) informed the Member States about the investigation into the implementation of On-the-Job Training (OJT) at Adria Tehnika (SI.145.100), Job Air Technic (CZ.145.0054), and Magnetic MRO (EE.145.0102), the ILT has taken additional measures.

After due consideration, the ILT decided to suspend the type rating endorsements of 116 Aircraft Maintenance Licences, effective 01 March 2025. The suspension will initially be for the duration of twelve (12) months in which the affected AML holders will have the opportunity to lift the suspension by either reperforming an adequate OJT or complying with the conditions of Exemption ILT-2025/989, issued by the ILT on 24 February 2025 pursuant to Article 71(2) of Regulation (EU) 2018/1139 of the European Parliament and of the Council. It must be noted that the exemption is subject to assessment by EASA and the Commission.

Attached hereto is the list of 116 AMLs on which the type rating endorsements have been suspended. The licence holders have been issued a licence adjusted to the suspension with the remaining basic (sub-)categories.

The Member States are requested to disseminate this information among the stakeholders under their oversight as appropriate.
