For multiple student registrations, a single e-mail is to be sent in for every student.

A copy of a proof of identity should be provided in the case the student does not have a Swedish personal identity number or a Swedish coordination number and does not have a Swedish flight crew licence, student permit or medical certificate.

Untrue affirmation

If you violate or attempt to violate the examination rules, this means that you may be found guilty of the offense of **untrue affirmation**. Violating the examination rules, or attempting to do so, is also considered cheating and may result in the Swedish Transport Agency failing your entire examination. In that case, you will also not be allowed to take any more exams in any of the EASA Member States for 12 months or more.
