Sweden

The operator-ID is subject to a registration fee and an annual recordkeeping fee.

If your operator-ID is still registered January 1st, the annual fee must be paid.

The invoice can be paid via bank transfer, all required information is available on the invoice.

Please note: If you leave Sweden or sell your UAS, your operator-ID is NOT automatically deregistered unless an expiration date is specified on your registration confirmation.

EU-Citizens

An operator-ID registered in another European Union/EASA member state is valid in any EASA member state including Sweden. If you do not already have an operator-ID, you shall apply for one in your country of residence.

Non EU-Citizens

If you do not already have an operator-ID registered in Sweden or another European Union/EASA member state, you can apply for one in Sweden using this form. Do not forget to attach a **copy of your passport**.

Organisations

A registration certificate or similar must be attached to validate the representative's role in the organisation. For third country organisations, a **copy of the representative's passport** must be included.
