### Filer/Contact person

The filer/contact person is the party submitting the matter to the Swedish Transport Agency. This can be a business or a person: the seller, buyer, broker or some other initiated party. State the filer's name and address as well as their contact details, so we can contact them if there are any questions.

### Owner(s)

Information must be provided about all of the vessel's owners. If there are several owners, use the *Other information* box to state their names and addresses. If the space in the box is insufficient, use *a separate sheet of paper*, and make a note on the form that is has an *annex*.

If the vessel has several owners the form must be signed by all of them.

### Reason for deregistration

Note that Swedish boats whose length over all exceeds 15 metres must by law be registered in the Register of Shipping. If a boat in this category has been sold to another Swedish owner it cannot be deregistered from the Register of Shipping; instead the new owner must register their acquisition of it. Boats whose length over all is under 15 metres must also be registered, if they are used professionally and under certain other circumstances.

### Acquirer

### Other information

Use this box to state whether there are several owners, provide any information that might be helpful to the processing of the case, etc.

### Signature(s)

The person or persons signing have to be authorised signatories for the applicant if the applicant is not a natural person.
