

Initial assessment

An initial assessment is required and needs to be approved by the Swedish Transport Agency, as the type approval authority in Sweden, to issue type approvals for a manufacturer. The Swedish Transport Agency must verify that the manufacturer has satisfactory methods and routines to ensure that type approved products conform with the approved type when in production.

Please note that it is only a manufacturer that can apply for an initial assessment.

A manufacturer should work according to a quality management system that meets the requirements of ISO 9001:2015 or equivalent. For more information regarding the requirements for each heading below, we refer to the standard you use.
